





Erga Omnes is a Latin expression meaning "for all" or "against all". International rights in international law have been used as a legal term describing obligations owed to countries as a whole. Erga Omnes is a commitment to a general and undeniable interest in preserving fundamental rights and preventing violations. Therefore, every country has the right to complain about violations. Examples of Erga Omnes standards are piracy and genocide. This concept was recognized in the International Court's decision on the Barcelona traction case [1] [(Belgium v. Spain) (second phase) in paragraph 33 33]: ...Human personhood, including protection from slavery and racial discrimination.

Some relevant property rights are reflected in general international law..., others are provided by international instruments of a universal or quasi-universal nature. Examples in the advisory statement of July 9, 2004 stated that the International Court of Justice "the right of peoples to self-determination" is a real ergomnes.
